RDOS Evacuation Alerts RESCINDED – Snowy Mountain Wildfire Village of Keremeos, Rural Keremeos, Cawston & Chopaka Road

The **EVACUATION ALERT**, pursuant to the Emergency Program Act, issued by the Village of Keremeos on July 31, 2018 is **RESCINDED** for **all properties shown in the map below**, and which are situated on the south side of Highway 3 and 7th Ave through the Village.

The **EVACUATION ALERT** in the vicinity of rural Keremeos in Electoral Area “G” and Cawston in Electoral Area “B”; issued on July 31, 2018 is **RESCINDED** for the **properties shown in the attached map** on the south / southwest side of Highway 3 extending from 10th Ave in west rural Keremeos to the northern boundary of the Lower Similkameen Indian Band lands.

The **EVACUATION ALERT**, pursuant to the Emergency Program Act, issued by the Regional District Okanagan-Similkameen in the vicinity of Chopaka Road, south of the community of Cawston in Electoral Area “B,” issued on August 6, 2018 is **RESCINDED** for the following properties:

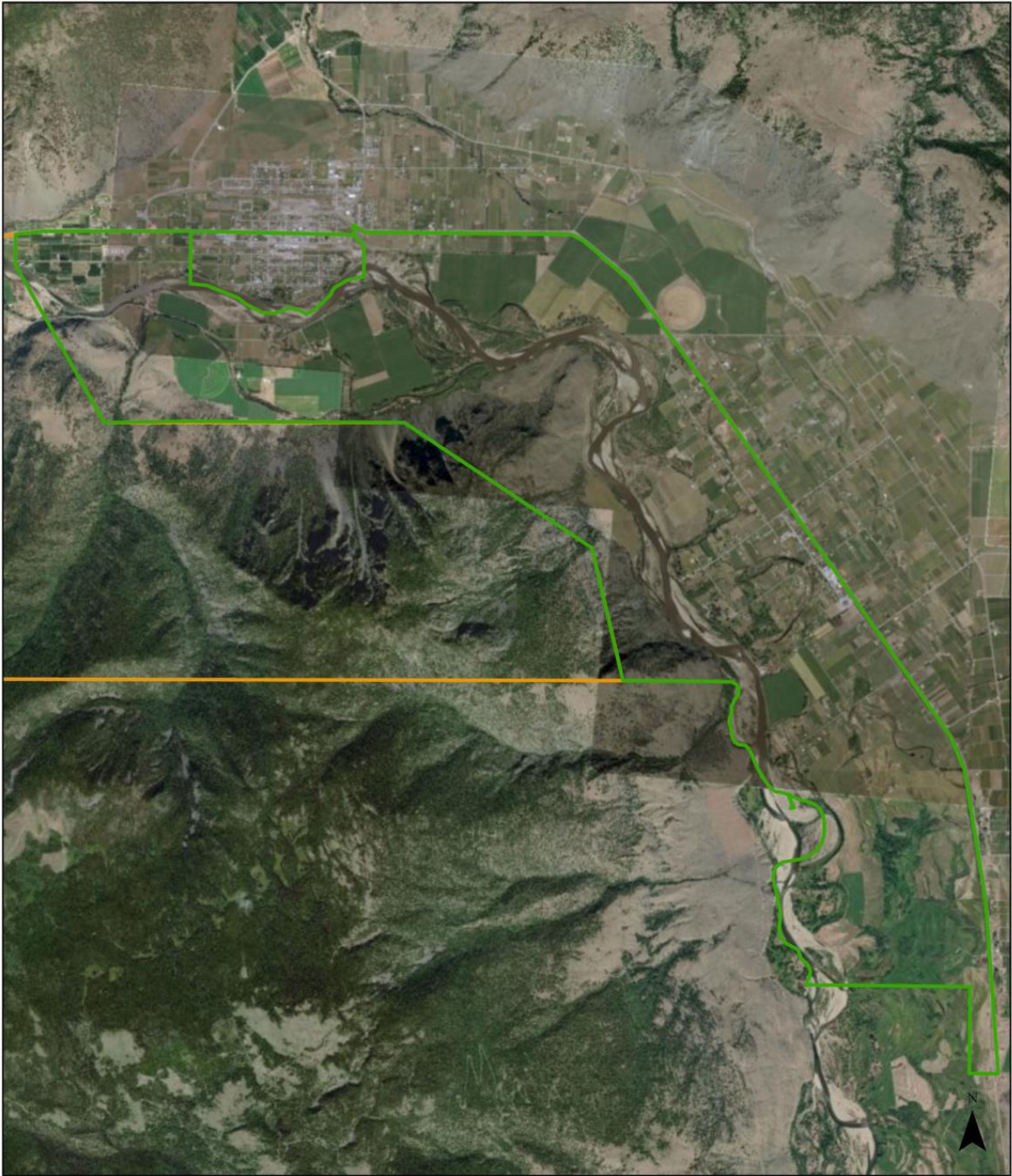
