EVACUATION ALERT RESCINDED for 61 Properties in Electoral Area "G"

The Regional District of Okanagan-Similkameen (RDOS) advises that the threat of flooding has been reduced and the potential danger to life, health and property has diminished in certain areas. The Evacuation Alert, in the vicinity of Keremeos Creek, North and East of the Village of Keremeos in Electoral Area "G", pursuant to the Emergency Program Act issued on May 1st, 2018 to the properties listed below has been RESCINDED.

The residents in the list below are no longer on Evacuation Alert.

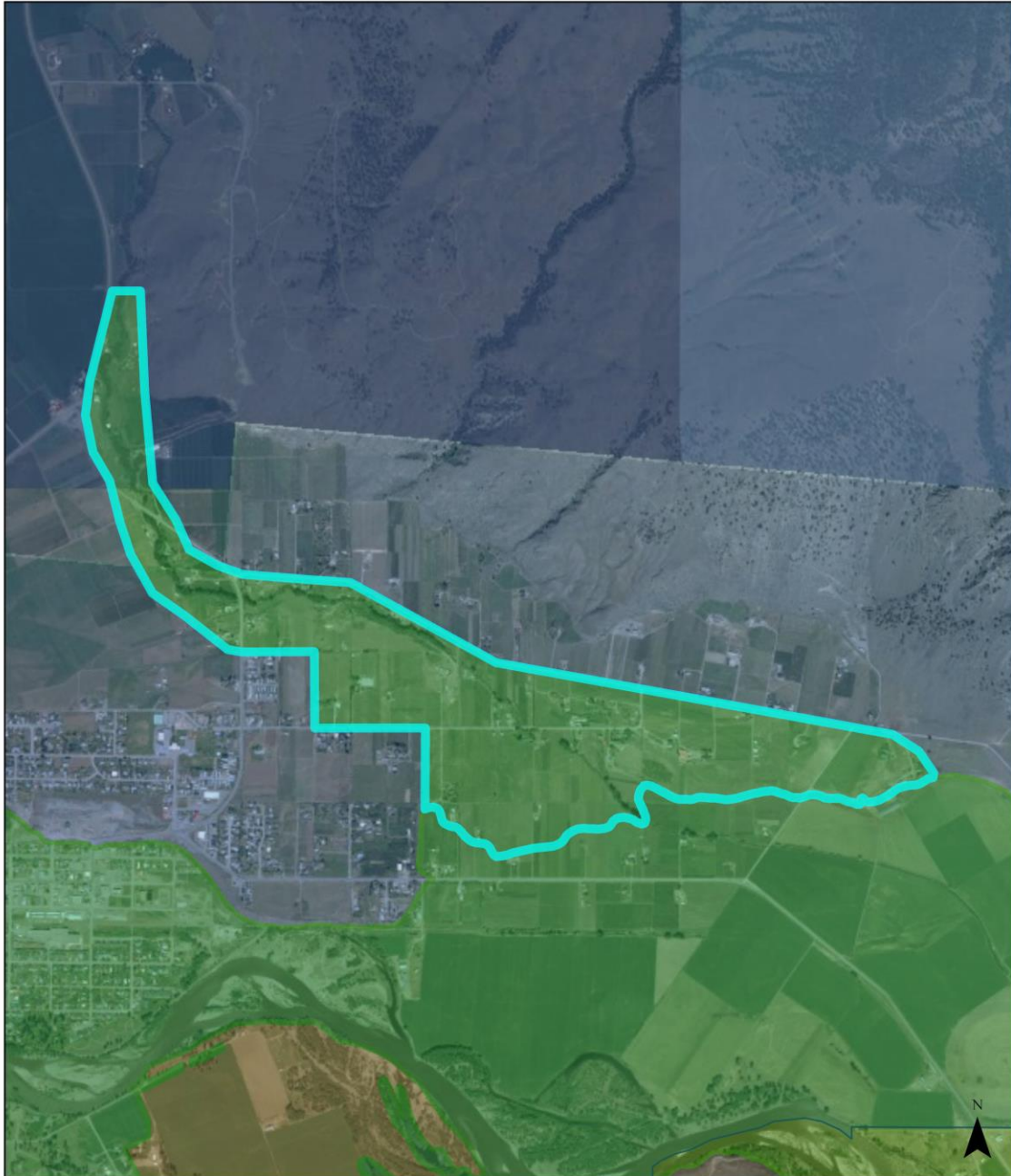
