

NOTICE TO ALL NARAMATA IRRIGATION CUSTOMERS

IRRIGATION TURN – ON

The Regional District of Okanagan-Similkameen Public Works crew will commence irrigation turn-on the week of:

April 22, 2019

In the event you do not wish to have your private system pressurized please take whatever precautions are necessary to protect your private systems.

Please take note of the following before activating your private system:

- **FLOW REGULATORS** are required on all irrigation services. Operators will be checking for the installation of these flow regulators before turning on services.
- **BACKFLOW PREVENTION** is required for all fertigation, underground sprinkler systems, commercial/ industrial connections and spray fillers.

Please note that all test reports for backflow preventers must be submitted within thirty (30) days of the irrigation turn-on date.

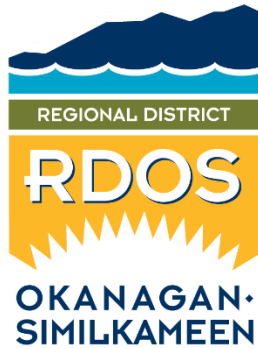

Failure to do so could result in a water turn off to properties in default of this requirement.

Warmer temperatures and irrigation turn-on will result in a larger volume of water flowing through the water lines that may cause temporary discoloration of the water. To avoid any inconvenience, run your cold water tap for a few minutes prior to laundering during the week of April 22, 2019.

NOTICE TO ALL NARAMATA DOMESTIC WATER CUSTOMERS

STAGE 1 WATER RESTRICTIONS NOW IN EFFECT FOR DOMESTIC USERS

The Regional District of Okanagan-Similkameen reminds residents that water restrictions are in effect for Naramata for the duration of the irrigation season effective April 1, 2019.

Residents are *reminded* to water on the odd/even system according to street address. Those with even house numbers can water on even calendar days and vice versa for odd house numbers.

- For manual sprinklers, lawn watering must only occur before 10:00 a.m. and after 6:00 p.m. on your watering day.
- For those with automated timed systems, your irrigation must start after 12:01 a.m. on your watering day and be finished before 10:00 a.m. that day.
- Hand watering of flowers, shrubs, gardens, and trees is permitted during the day.

THESE RESTRICTIONS APPLY TO DOMESTIC WATER SYSTEM USERS ONLY

The Regional District is empowered to turn off the supply of water to any person who violates this notice.
