BYLAW NO. 1409, 1993

A bylaw to amend the Okanagan Falls Specified Area Sanitary Sewer System Local Service Establishment Bylaw No. 1239, 1991.

WHEREAS Bylaw No. 1239, cited as the **Okanagan Falls Specified Area Sanitary Sewer System Local Service Establishment Bylaw No. 1239, 1991**, established the Okanagan Falls Sanitary Sewer Local Service;

AND WHEREAS pursuant to Section 802 of the Municipal Act, the Regional Board of the Regional District of Okanagan-Similkameen may by bylaw, amend an established local service;

AND WHEREAS the owner of: Lot 1, Plan 24048, SL 37, DL 2710, Exc. Plan 27179, 41143 & 43559, SDYD; Lot 1, Plan 43559 DL 2710, SDYD; and Lots 11 & 12, Plan 43303, DL 10, SDYD, has petitioned the Regional Board to extend the boundaries of the Okanagan Falls Sanitary Sewer System Local Service Area;

AND WHEREAS the Regional Board also intends to extend the boundaries of the service area to include: Lot 1, Plan 24048, SL 37, DL 2710, Exc. Plan 27179, 41143 & 43559, SDYD; Lot 1, Plan 43559 DL 2710, SDYD; and Lots 11 & 12, Plan 43303, DL 10, SDYD;

NOW THEREFORE, the Regional Board of the Regional District of Okanagan-Similkameen in open meeting assembled **ENACTS** as follows:

1. That the **Okanagan Falls Specified Area Sanitary Sewer System Local Service Establishment Bylaw No. 1239, 1991**, be amended by deleting Sections 2 and 3 in their entirety and replacing them with the following:

2. BOUNDARIES OF THE SERVICE AREA

The boundaries of the local service area are the boundaries of a portion of Electoral Area 'D' as outlined on the attached Schedule 'A' forming and being a part of the bylaw.

3. PARTICIPATING AREA

Electoral Area 'D' as outlined on attached Schedule 'A' includes the participating area.

2. CITATION

This bylaw may be cited as the "Okanagan Falls Sanitary Sewer System Local Service Establishment Bylaw No. 1239, AMENDMENT BYLAW No. 1409, 1993."
