REGIONAL DISTRICT OF OKANAGAN-SIMILKAMEEN

BYLAW NO. 1690, 1996

A bylaw to establish a local service for the supply, treatment, conveyance, storage and distribution of water in the Olalla area of Electoral Area 'G'.

WHEREAS pursuant to Section 788(1)(b) of the *Municipal Act*, the Regional District of Okanagan-Similkameen may, by bylaw, establish and operate as a local service, the supply, treatment, conveyance, storage and distribution of water;

AND WHEREAS the Board of Directors of the Regional District of Okanagan-Similkameen wishes to proceed under Section 794 of the *Municipal Act*, to establish the supply, treatment, conveyance, storage and distribution of water as a local service for the Olalla Water System Local Service Area of Electoral Area 'G' as outlined on Schedule 'A' attached to this bylaw;

AND WHEREAS pursuant to Section 796 of the *Municipal Act*, the Board of Directors of the Regional District of Okanagan-Similkameen, in respect to the Olalla Water System Local Service Area in Electoral Area 'G' has obtained the assent of the electors;

AND WHEREAS the Director of Electoral Area 'G' has consented in writing to the adoption of this bylaw;

NOW THEREFORE the Board of Directors of the Regional District of Okanagan-Similkameen in open meeting assembled, ENACTS as follows:

1. ESTABLISHMENT OF LOCAL SERVICE

The Olalla Water System Local Service is established.

2. WATER SYSTEM LOCAL SERVICE

The Board of Directors of the Regional District of Okanagan-Similkameen is empowered and authorized to provide for the supply, treatment, conveyance, storage and distribution of water for the Olalla Water System Local Service Area, and without limiting the generality of the foregoing, to enter into contracts with such authorities and companies as may be necessary or appropriate to implement the Olalla Water System Local Service.

3. BOUNDARIES OF THE SERVICE AREA

The boundaries of the Olalla Water System Local Service Area are within a portion of Electoral Area 'G' as outlined on Schedule 'A' attached to and forming part of this bylaw.

4. PARTICIPATING AREA

The Olalla Water System Local Service Area is located entirely within the boundaries of Electoral Area 'G'.

5. COST RECOVERY METHOD

The annual costs for the Olalla Water System Local Service shall be recovered pursuant to Sections 804(1)(a) and (c) of the *Municipal Act* as follows:

- (a) by the requisition of money in the participating area within a portion of Electoral Area 'G', as outlined on attached Schedule 'A', under Section 806(4) of the *Municipal Act*, to be collected by a property value tax on the net taxable value of land only within the participating area to be levied and collected under Section 810.1(I) of the *Municipal Act* for the purpose of recovering debt servicing costs.
- (b) by the imposition of fees and other charges that may be fixed by separate bylaw for the purpose of recovering operation, maintenance, connection, disconnection and reconnection costs.

6. LIMIT

The maximum amount that may be requisitioned under Section 804(1)(a) of the *Municipal Act* for the Olalla Water System Local Service shall not exceed \$106,411.00.

7. CITATION

This bylaw may be cited for all purposes as the "Olalla Water System Local Service Establishment Bylaw No. 1690, 1996".



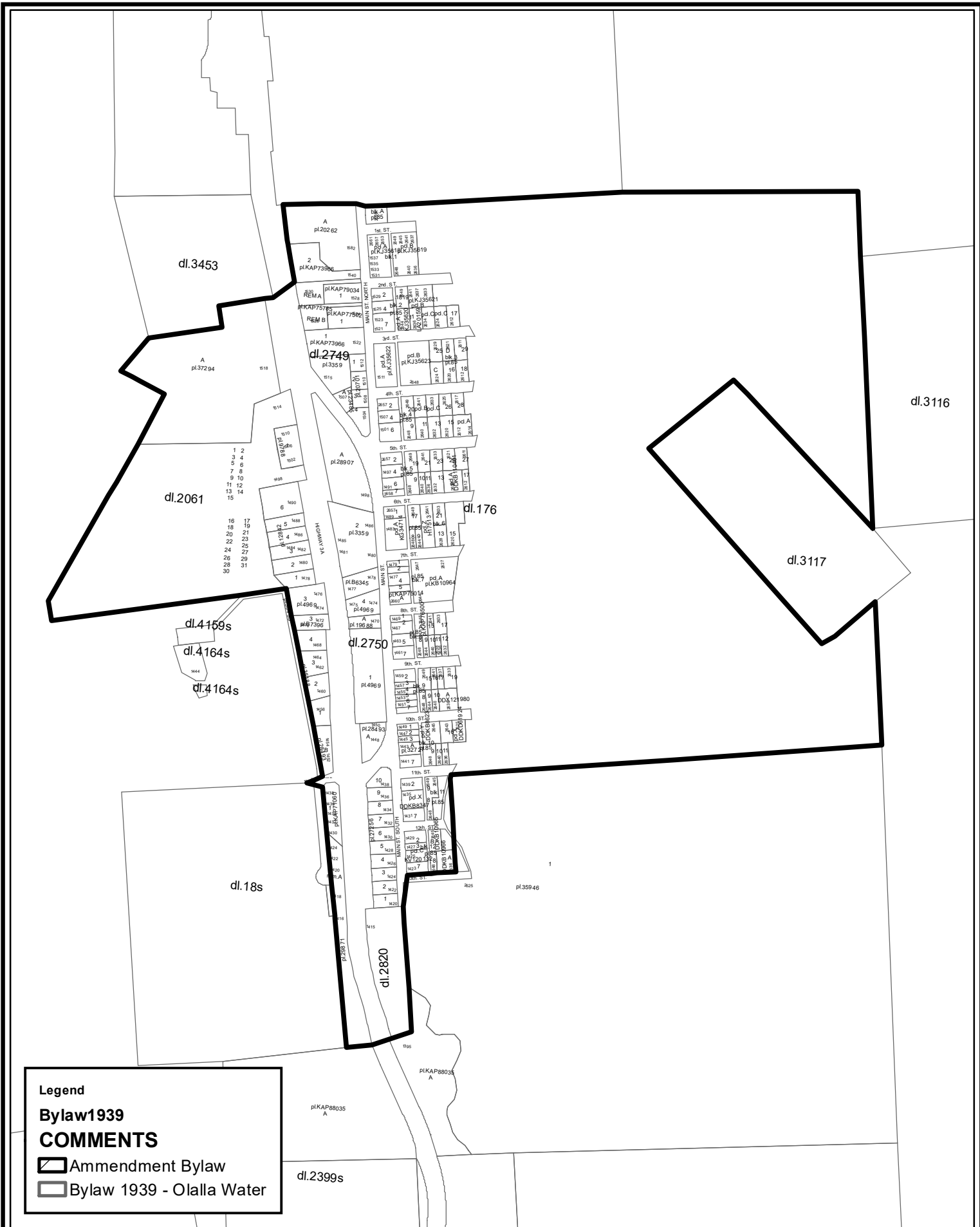
