BYLAW NO. 2023.01, 2007

A bylaw to amend Naramata Cemetery Bylaw No. 2023

WHEREAS pursuant to Section 797.1(2) of the *Local Government Act*, and to Regional District of Okanagan-Similkameen Bylaw No. 1617, 1995, the Regional Board has established the service of the Naramata Cemetery;

THEREFORE BE IT RESOLVED the Board of the Regional District of Okanagan-Similkameen, in open meeting assembled, **ENACTS** as follows:

1. CITATION

1.1 This bylaw shall be cited for all purposes as “Regional District Okanagan Similkameen Naramata Cemetery Regulation Amendment Bylaw No. 2023.01, 2007”.

2. AMENDMENTS

2.1 Bylaw No. 2023 RDOS Naramata Cemetery Regulation Bylaw is hereby amended by:

(a) Adding under Section 1 Interpretation the following definitions:

Act” means the *Cemetery Interment and Funeral Services Act*, C.I.F.S.A Bill 3 -2004, as amended;

“Columbarium” means an above ground structure for the structure for the interment of cremated remains

“Scattering Gardens” means a designated area for the placement of non-recoverable, commingled cremated remains placed within an ossuary or scattered within the designated garden area.

(b) Deleting Section 3.1 in its entirety and replacing with the following:

3.1 A person may apply to the Cemetery Board for reservation of a Plot within the Naramata Cemetery, and upon payment of the fee prescribed in Schedule “A” shall be issued a Plot Reservation License for the use of a Plot, provided that an unallocated subdivided Plot is available. This reservation will be limited to a maximum of three (3).

- (c) Deleting Section 3.9 in its entirety and replacing with the following:
 - 3.9 Where a person has requested cancellation of a Plot reservation pursuant to section 3.8, the person shall be entitled to 80% refund of the amount paid, without interest, as evidenced in the Regional District's records, for the reservation.
- (d) Deleting Schedule "A" and replacing it with the attached schedule "A"

SCHEDULE "A"

1. PLOT RESERVATION LICENSE FEES:

Burial Plot: resident (\$120 allocated to reserve)	\$450.00
Burial Plot non resident (\$240 allocated to reserve)	\$600.00
Cremation Plot: resident (40 allocated to reserve)	\$150.00
Cremation Plot non resident (\$80 allocated to reserve)	\$200.00

2. INTERMENT OPENING AND CLOSING FEES:

Burial Plot: - 240 cm depth or greater	\$600.00
Cremation Plot:	\$100.00

3. EXHUMATION OR DISINTERMENT OPENING AND CLOSING FEES:

Burial Plot:	\$650.00
Cremation Plot:	\$150.00

**4. OPENING OR CLOSING FOR INTERMENT/
EXHUMATION/DISINTERMENT OTHER THAN
DURING NORMAL BUSINESS HOURS:**

Fee in addition to that applicable under item 2 or 3 above for burial plot:	\$200.00
Fee in addition to that applicable under item 2 or 3 above for cremation plot:	\$200.00

5. ISSUANCE OF LICENSE/PERMIT OTHER THAN DURING NORMAL BUSINESS HOURS, OR LESS THAN 24 HOURS PRIOR TO SCHEDULED INTERMENT:

Fee in addition to that applicable under item 1, 2 or 4 above: \$100.00

6. INSTALLATION OF MEMORIAL MARKER: \$ 85.00
(\$10 allocated to reserve)

7. GRAVE LINER: \$250.00

8. Picture of interred for internet - one time charge (optional) \$ 50.00

9. Text, for internet to a maximum of 200 words, (optional) \$ 50.00
